915 Minutes of council meeting of 16th January 2017

916 Code of Conduct and the Ethical Framework

917 Actions from the last meeting

917.1 The Clerk's timesheet was approved.

917.2 Monthly inspection of Council owned land

All Council Land was inspected and there were no issues to report.

917.3 Snicket

The Clerk contacted the public footpaths department at NYCC concerning the deteriation of the snicket who instructed her to submit a form with photos. The Council is still waiting for the NYCC to respond.

917.4 Budget

The Council considered the possibility of having a bus shelter at the bus stop near the garage travelling towards Kirkbymoorside. The Clerk contacted highways to inquire about the feasibility of this project and what type of bus shelter we could have and also would it be possible to move the bus stop to Colley Pond.

The Clerk was asked to find out the requirements regarding raised/lowered footpaths at the bus stop, and to get a rough quote as to the overall cost of having this sited at Colley Pond with the necessary adjustments to pavements etc. Councillor Edwards agreed to give a quote on the job.

917.5 Mobile Mast

The company are interested in the land that is on offer at Marr Pond or The Quarry and want to set up a multi site meeting with the Council. The Clerk sent a letter of endorsement to the company

The company raised its offer to £32,500.

There is a private landowner interested in this offer as well as the Council and the regional manager has said this may take a few months before we hear anything. Should there be any action on this.

Councillor Windress will ask RDC solicitor if he could help with this arrangement.

917.6 VAS- vehicle activated signs

The Clerk was asked to contact Darren Griffiths- senior engineer to enquire if the Council could purchase a sign rather than pay the £3,500 administrative costs every four years. The Clerk emailed and telephoned Mr Griffiths- he replied that we could not purchase a VAS sign. Hovingham say they won't be having one at all and Beadlam are contacting Val Arnold.

The Clerk was asked to contact Val Arnold and also to enquire about contractors who supply VAS.

917.7 The Council agreed a sum of £30 per year to Steven Wood for the cost of electricity to run the defibrillator. Councillor Windress will ask Mr Woods for an invoice.

917.8 School Transport Hazard

It was brought to the attention of the Council that the school buses, Perry's coaches, were knocking the pupils walking down the road with the wing mirrors.

The Chair Russ Dickinson and Councillor Debbie Swift attended a meeting with the headmaster and were satisfied that he had done everything he could to find a solution to this problem.

They also found out that the school had planning permission to accept 100 more pupils. The Council has not been informed and the Clerk was instructed to contact NYCC.

The Clerk was asked to contact the police and ask for advice about coaches mounting the pavement.

The Clerk and Debbie Swift met with John Putsey to ascertain where exactly the dropped curbs would go. He said they would be done in the next tax year.
