**785 Agenda**

**787 Minutes of council meeting of 20<sup>th</sup> July 2015**

The Chairman agreed the minutes of the meeting of 20th July 2015.

The Chairman signed the minutes and the Clerk added them to the minute book.

**788 Code of Conduct and the Ethical Framework**

John Windress declared an interest in the Site Development Document

**789 Actions from the last meeting**

789.1 The Clerk's timesheet was approved.

789.2 Monthly inspection of Council owned land

All Council Land was inspected and there were no issues to report.

Bus shelter update – the flagstones are laid and the bus shelter roof has been finished off. The Council is waiting for the seats and table to be put into place.

The Clerk to contact Lady Clarissa, regarding the field maple, early in the autumn. Lady Clarissa has said that she would like to have a brass plate by the tree.

### 789.3 Wolds View

Following on from a complaint from a parishioner about an extension to a roof at Wold's View, this has yet to be assigned to anyone at RDC. Still has not been assessed due to lack of staff. Ongoing

### 789.4 Housing

Proposed development of 27 houses in the field next to Beckett Close.

A draft letter has been drawn up to help with the objection process. This may need to be amended when the application is received.

No update on this as yet.

### 789.5 Site Development Document

This document will be out at the end of September. We will then have six weeks to study it and respond possibly on line. This will have to be looked at before the October meeting so it can be discussed in depth. The Clerk to email this to all Councillors when it is received.

### 789.6 Parish Council Website

The website is up and running and the team would appreciate any input e.g. news of events/clubs etc. The Councillors were happy with the website and remarked that it was clean and easy to use. The Clerk to ask schools to contact us with events and also to put a link to the Parish Council on their website.

### 789.7 Libby Capstick

A cherry tree will be planted on the grass at the start of Chapel Street in memory of Libby for her legacy of many years of service to the village.

The Clerk was asked to research the wording for the plaque and consult with Councillors.

### 789.8 Pinfold Hill

The Clerk has put a notice on the waste bin requesting that no dog poo bags are put in the bin. This seems to be ignored by some people. The dog bin is on hold for the time being. If we go ahead with this it will be located by the sand bin. The cost will be in the region of £200. The other alternative is to remove the waste bin.

The Council decided to ask Andrew Edwards to remove the waste bin and the Council will observe the situation.

## 789.10 Bridleway

I contacted Russ Varley of Paths N Yorkshire and he said they may have prior consent but any damage must be repaired by them.

The Council asked the Clerk to find out the status of the bridleway and it was suggested that a party of people should get together to repair the bridleway. A reply of our suggestion will be sent to Brian Simpson. Waiting for a response from NYCC.

The Clerk was asked to contact John Holken to see if he would dig out an area at the start of the bridleway and then the Council will arrange some hardcore to make a soak away.
